Tamerlaine Sanctuary & Preserve is the First Sanctuary in New Jersey to be Accredited by the Global Federation of Animal Sanctuaries



March 3, 2021 (Montague, NJ) - The Global Federation of Animal Sanctuaries (GFAS), the only globally recognized organization providing standards for identifying legitimate animal sanctuaries, awarded Accredited status to Tamerlaine Animal Sanctuary & Preserve as of March 1, 2021.

Accreditation signifies that Tamerlaine Animal Sanctuary & Preserve meets GFAS's rigorous and peer-reviewed animal care standards which are confirmed by a comprehensive site visit. Accreditation also signifies adherence to standards addressing the sustainability of the organization, ethical principles, finances, staffing, education outreach, security and safety and other operational aspects. The Accreditation status also provides a clear and trusted means for the public, donors, and grantors to recognize Tamerlaine Sanctuary as an exceptional organization.
