Founded in 1995, Horses' Haven is a 501(c)(3) in Howell, Michigan. Our Mission is to Rescue, Rehabilitate, Retrain and Re-home at risk equines. We assist law enforcement agencies and accept surrendered horses from owners. Our goal is to find every horse in our care a forever home through adoption. This is accomplished through medical rehabilitation and training to ensure each horse, rideable or not, has the skills needed to be a good equine citizen. We are passionate in educating law enforcement, providing free hands-on clinics to give them the skills to evaluate, document and handle horses. That also extends to our up-and-coming veterinarians, allowing students from Michigan State University School of Veterinary Medicine opportunities to gain hands-on treatment experience in a real-life farm setting. Our Board of Directors, a small staff, and more than 130 volunteers are the foundation of caring for up to 70 equines at any given time.
